# CALL FOR APPLICATIONS **Artistic residencies in the European Union**

# European Union Mobility Programme for Myanmar (EMPM)

The EMPM programme - funded by the European Union (EU) and implemented by DAAD (lead organisation), Campus France and Nuffic - plans to award scholarships for artistic residencies in the European Union for young Burmese artists. As a pilot initiative managed by Campus France, selected artists will receive a mobility scholarship to undertake a 6-month artistic residency in the EU. The full amount of the available scholarships is 2000 euros per month (covering living and accommodation costs). The EMPM programme will also cover travel costs to the EU of the selected scholarship holders and possible tuition fees during their artistic residency. The artistic residencies may start in late summer/early autumn 2023 at the earliest. The deadline for this call for applications is August, 27, 2023.

# Conditions to apply

Eligibility criteria

- Burmese nationality
- Application submitted through a secure channel by a cultural/humanitarian organisation based in Myanmar, the EU, or an ASEAN country or an EU Member State's embassy based in Myanmar or in an ASEAN country

Documents to provide through a secure channel

- Application form duly filled in (see attachment)
- CV and a motivation letter explaining the applicant's residency project (in English or French)
- Artistic portfolio or description/proof of the applicant's artistic work
- · Copy of passport

#### How to apply

Cultural/humanitarian organisations based in Myanmar, the EU, or an ASEAN country, or EU Member States' embassies based in Myanmar or in an ASEAN country may send an email to empm@campusfrance.org indicating their willingness to submit an application on behalf of one or more Burmese artists. The subject line of such an email should contain the following information: EMPM Artistic residencies. Campus France will reply to this email sending the detailed instructions on how to submit applications through secure channels. If the application is eligible and selected, Campus France will contact the applicant and/or the submitting organisation shortly afterwards with information on the further steps for the setting up of the funded artistic residencies.

#### Selection criteria for artists

Eligible applications will be evaluated according to the following selection criteria:

Criteria	Scoring (whole and half-points are possible)
Motivation and residency project	Up to 40 points
Artistic portfolio or description/proof of the artistic work	Up to 30 points
Knowledge of the English language	Up to 20 points
Knowledge of the French language or other European language	Up to 10 points

A threshold of 50 points is necessary for an application to be placed in the ranking list.







The available scholarships will be awarded to applicants following the order of the ranking list. A reserve list will also be drawn up. Campus France will propose to the selected artists one or more options for their artistic residency. The recipients of an EMPM scholarship for an artistic residency in the EU will sign an agreement with Campus France upon confirmation of their choice.

#### Host institutions for artistic residencies in the EU

Artistic residencies organised and supervised by officially recognised public or private art schools will be given priority for funding. Previous experience in hosting and supporting artists from conflict-affected countries will be evaluated favourably. Strong links with similar organisations in other EU countries will be assessed positively, in order to offer the selected artists the possibility to carry out a short stay during the residency in a second European country, or to develop joint projects in an international environment. The residencies selected to host scholarship holders will sign an agreement with Campus France before the beginning of the artistic residency.

#### Minimum eligibility and selection criteria for artistic residencies

- An organisation offering artistic residencies in any artistic field
- Experience in hosting artists from conflict-affected countries and offer of support measures
- Possibility to provide support in English
- Strong links with similar organisations in other EU countries

### **Engagement**

It is the responsibility of the selected artists requiring a visa to make the necessary consular procedures on time to obtain a visa for the EU. Campus France cannot guarantee its delivery. For this reason, in the event of a visa refusal, the artist must inform Campus France without delay. No costs will be reimbursed to artists who are not able to take part in the EMPM programme for whatever reason.

## Privacy and personal data protection policy

Campus France will only save their personal data for the amount of time that is required to fulfill the purposes for which they were collected or to comply with all applicable legal obligations. The organisations' submitting the applications on behalf of the applicants and the applicants have the right to ask Campus France to grant them access to their personal data at any time, the right to correct or erase them, the right to restrict their processing, the right to object to their processing and the right to request their personal data portability.
